



## Privacy Policy

This Privacy Policy has been compiled to better serve those who are concerned with how their 'Personally Identifiable Information' (PII) is being used online. PII, as described in US privacy law and information security, is information that can be used on its own or with other information to identify, contact, or locate a single person, or to identify an individual in context. Please read our privacy policy carefully to get a clear understanding of how **Cerule International LLC** ("Cerule") and any of its present or future subsidiaries collect, use, protect or otherwise handle your PPI in accordance with our website. This Policy does not apply to information collected by Cerule by or through any other means, such as information collected offline.

### **What personal information do we collect from our blog, website or app?**

When ordering or registering on our site you may be asked to enter your name, email address, postal address (including billing and shipping addresses), phone number, credit card information, social security number or other details. We recognize the confidential nature of the Personal Information in its care and is accountable for the compliance of itself and its directors, officers, management, employees, representatives and agents including consultants and independent contractors in protecting this Personal Information.

### **When do we collect information?**

We collect information from you when you register on our site, place an order, subscribe to a newsletter, open a Support Ticket, enter information on our site or provide us with feedback on our products or services

### **How do we use your information?**

We may use the information we collect from you in the following ways:

- to quickly process your transactions;
- to send periodic emails and/or SMS messages regarding your order or other products and services;
- to tell you about our operations, services, and programs;
- to provide you real time reporting on your Cerule business via our back-office
- to allow you to use, communicate and interact with others on our website; and
- for our internal business purposes, such as data analysis, audits, enhancing our website, improving our services and identifying usage trends.

We may disclose your PII:

- to affiliated companies but not for direct marketing purposes;
- to third-party service providers who provide services to us, such as web site hosting, data analysis, payment processing, order fulfillment, infrastructure provision, information technology services, customer service, email delivery services, credit card processing, auditing, training, and other similar services for the purpose of providing these services to us or on our behalf;
- to other Cerule Independent Business Owners (IBOs) in your upline via our Cerule back-office

([www.mycerule.com](http://www.mycerule.com)) for the purpose of providing accurate information to IBOs on activity in their downline;

- to a third party in the event of any reorganization, merger, sale, joint venture, assignment, transfer or other disposition of all or any portion of our business, assets or stock (including in connection with any bankruptcy or similar proceedings); and
- we may provide PII in response to a court order, subpoena, or government investigation. We also reserve the right to report to law enforcement agencies any activities that we believe to be unlawful or suspicious. We may release Personal Information when we believe that such release is reasonably necessary to enforce or apply our Terms of Use or to protect the interests, rights, property, and safety of others and ourselves.

We may also collect **Non-Personal Information which** does not reveal your specific identity, such as:

- browser information
- information collected through cookies, pixel tags and other technologies
- demographic information and other information provided by you

For example, Cerule

- collects information such as your computer type (Windows or Macintosh), screen resolution, operating system version and Internet browser type and version and your demographic information. This information does not personally identify you to anyone else.
- may aggregate PII so that the aggregated information does not personally identify you to anyone else.

Your PII may be stored and processed in any country where we have operations, and by interacting with us and providing us with any PII, you consent to the transfer of information to countries outside of your country of residence, including the United States, which may provide for different data protection rules than in your country

### **How do we protect your information?**

Our website is scanned on a regular basis for security holes and known vulnerabilities in order to make your visit to our site as safe as possible.

We use regular Malware Scanning.

Your personal information is contained behind secured networks and is only accessible by a limited number of persons who have special access rights to such systems, and are required to keep the information confidential. In addition, all sensitive/credit information you supply is encrypted via Secure Socket Layer (SSL) technology.

We implement a variety of security measures when a user places an order enters, submits, or accesses their information to maintain the safety of your personal information.

All transactions are processed through a gateway provider and are not stored or processed on our servers.

### **Do we use 'cookies'?**

Yes. Cookies are small files that a site or its service provider transfers to your computer's hard drive through your Web browser (if you allow) that enables the site's or service provider's systems to recognize your browser and capture and remember certain information. For instance, we use cookies to help us remember and process the items in your shopping cart. They are also used to help us understand your preferences based on previous or current site activity, which enables us to provide you with improved services. We also use cookies to help us compile aggregate data

about site traffic and site interaction so that we can offer better site experiences and tools in the future.

### **We use cookies to:**

Compile aggregate data about site traffic and site interactions in order to offer better site experiences and tools in the future. We may also use trusted third-party services that track this information on our behalf.

You can choose to have your computer warn you each time a cookie is being sent, or you can choose to turn off all cookies. You do this through your browser settings. Since browser is a little different, look at your browser's Help Menu to learn the correct way to modify your cookies.

If you turn cookies off, some features will be disabled. It won't affect the user's experience that make your site experience more efficient and may not function properly.

However, you will still be able to place orders.

### **Third-party disclosure**

We do not sell, trade, or otherwise transfer to outside parties your Personally Identifiable Information unless we provide users with advance notice. This does not include website hosting partners and other parties who assist us in operating our website, conducting our business, or serving our users, so long as those parties agree to keep this information confidential. We may also release information when it's release is appropriate to comply with the law, enforce our site policies, or protect ours or others' rights, property or safety.

However, non-personally identifiable visitor information may be provided to other parties for marketing, advertising, or other uses.

## **COPPA (Children Online Privacy Protection Act)**

This principle requires not only that individuals have enforceable rights against data users, but also that individuals have recourse to courts or government agencies to investigate and/or prosecute non-compliance by data processors.

## **CAN SPAM Act**

The CAN-SPAM Act is a law that sets the rules for commercial email, establishes requirements for commercial messages, gives recipients the right to have emails stopped from being sent to them, and spells out tough penalties for violations.

**We collect your email address in order to:**

- Send information, respond to inquiries, and/or other requests or questions
- Process orders and to send information and updates pertaining to orders.
- Send you additional information related to your product and/or service

**To be in accordance with CANSPAM, we agree to the following:**

- Not use false or misleading subjects or email addresses.
- Identify the message as an advertisement in some reasonable way.
- Include the physical address of our business or site headquarters.
- Monitor third-party email marketing services for compliance, if one is used.
- Honor opt-out/unsubscribe requests quickly.
- Allow users to unsubscribe by using the link at the bottom of each email.
